ORDINANCE 03-04-01

AN ORDINANCE ADOPTING KOSCIUSKO COUNTY AREA PLANNING ORDINANCES

WHEREAS, the Kosciusko County Area Plan Commission has heretofore adopted, after due public hearing thereon, a Comprehensive Plan for Kosciusko County, Indiana, pursuant to Indiana Code 36-7-500 et seq.; and,

WHEREAS, the Kosciusko County Area Plan Commission has heretofore adopted, after due public hearing thereon, a Zoning Ordinance pursuant to Indiana Code 36-7-4-600 et seq., a Subdivision Control Ordinance, pursuant to Indiana Code 36-7-4-700 et seq., a Mobile Home Park Ordinance, pursuant to Indiana Code 36-7-4-1100 et seq., a Flood Control Ordinance, pursuant to Indiana Code 14-28-3 et seq., and a Storm Water and Erosion Control Ordinance pursuant to Indiana Code 36-7-4-600 et seq.; and

WHEREAS, said Kosciusko County Area Plan Commission did certify said ordinances to the Town of Silver Lake, Indiana on the 25th day of March 2003; and

WHEREAS, the Town of Silver Lake is desirous of adopting said Comprehensive Plan, Zoning Ordinance, Subdivision Control Ordinance, Mobile Home Park Ordinance, Flood Control Ordinance and Storm Water and Erosion Control Ordinance as certified by the Kosciusko County Area Plan Commission.

NOW THEREFORE, BE IT ORDAINED, by the Town Council of the Town of Silver Lake, Indiana:


Section 1. That said Comprehensive Plan, Zoning Ordinance, Subdivision Control Ordinance, Mobile Home Park Ordinance, Flood Control Ordinance, and Storm Water and Erosion Control Ordinance, as certified by the Kosciusko County Area Plan Commission, be and the same are hereby adopted by the Town of Silver Lake, to become effective upon the 9TH day of April, 2003.

Section 2. That the Town of Silver Lake reserves the right, at its discretion, to with draw from the Area Plan jurisdiction in the future, should it desire to do so.






